WAIVER OF LIABILITY

Release & Waiver of Liability, Assumption of Risk, Indemnity & Parental Consent Please read carefully and sign below to indicate your agreement. IN CONSIDERATION of being permitted to participate from time to time in any or all of the following activities offered by The Gunslinger Academy LLC, or any affiliate of such entities: Gridiron 7v7 League, Gunslinger QB Challenge, Perfect Timing Combines, Speed, agility, strength, Quarterback training, Skills Training, weight lifting Exercise/Fitness classes, and/or personal fitness training, Sport specific training (including, but not limited to, flag-football, 7v7 football, or tackle football) Camps (collectively or individually, as applicable, referred to herein as the "Activity"), I, for myself and for my personal representative, assigns, heirs, and next of kin: Assume all of the risks of participating in the Activity, including by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of persons or entities being released, from dangerous or defective equipment or property owned, maintained or controlled by them, or because of their possible liability without fault. Certify that I am physically fit and have not been advised to not participate by a qualified medical professional. Acknowledge that this Accident Waiver and Release of Liability Form will be used by the organizers of the Activity and that it will govern my actions and responsibilities in connection with the Activity. In consideration of my application and permitting me to participate in the Activity, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (A) I WAIVE, RELEASE, AND DISCHARGE the Releasees (as defined in this paragraph) from any and all liability, including but not limited to, liability arising from my participation in the Activity or the negligence or fault of any of the Releasees or my death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me including my traveling to and from the Activity.
